537 Fountain Street Carr Property - The property owner was given a 30 day extension to make the curb box accessible, he has been working on it and has spoken to Foreman Belotti.

Chuvala Sherriff Sale has been Postponed again and we are waiting to hear about a new date.

38 Riverside Court possible Sheriff Sale – We have a lot of years of back taxes but they are barely worth the cost of a Sheriff Sale for the property. Manager Ulanowicz was discussing with the school district. Solicitor Dalfonso suggested that we look into potential buyers for the property. Sometimes they are willing to pay for the Sheriff Sale to purchase the property reasonably.

Mobile Vendor Permits, not just food – Do we want random wares to be sold on the side of the road in town. Council does not want this. So when it happens it will be a zoning violation.
