- 3) Sidewalk at the Park Councilman Simmons did a walk through with Senate. Senate is working on preparing the bid docs. We would like to have the area in front of the dumpster as an add on.
- 4) Cross Walk Signs We will need to order a study from PennDot but we are waiting on more activity.
- 5) Full Service Network Video Storage Manager Ulanowicz shared that she has ordered the storage and we are waiting for the equipment to be installed. They are supposed to come Thursday to install it.

Public Works

- 1) The guys are replacing water meters trying to finish up the meter replacements. We have about eight set up for next week.
- 2) Public works has repaired a couple of water lines that were leaking.
