## Strategic Planning

 Allegheny Together kickoff meeting with the Business Advisory Committee went well, we are gathering information to be ready for the next meeting. They asked us to get a list of the business together for them and we sent it off to them.

### **Public Safety**

- 1) Fire Department the new engine is being painted by Pitt-Ohio.
- 2) Fire Safety Inspections Fire Marshall McBriar and Deputy Marshall Simmons finished apartment buildings; they are going to start the inspections for the businesses, beginning with the businesses along Freeport Rd. We do the fire inspections every two years.
- 3) Full Service Network Video Storage Manager Ulanowicz asked FSN if it was possible to store the video and sound and they are capable; We would need to purchase an Angel Box for \$159, there is a \$30/ year subscription; and cloud storage is \$6.40 for 3 days or \$32.99 for 3 months.
- 4) Fire Study Results Kathy met with Chuck Miller and O'Hara Township; We should have the results by the end of July.
- 5) Cross Walk Signs Manager Ulanowicz and Councilmen Simmons met with PennDot, 3 of the cross walks are no problem and we can put what we want there, The one in front of the Borough Building is a middle of the block crosswalk and PennDot has no record of approval for it so we will need to do a study to put the sign there.
