  - Recommend to award CD-48 Water Valve Replacement Bids opened on October 20<sup>th</sup>. The low bid was Osiris Enterprises at \$119,108. Gordon spoke to Lynn, they have had some problems but Gordon suggests awarding the bid anyways. The bid was about 8% higher than we had estimated.

201 Summit Drive Update – Manager Ulanowicz said it is coming along, they have poured the driveway, but there is no new update at this time.

'CLR' Common Level Ratio – No new word. There is some sort of an appeal by Pittsburgh Public Schools but we do not know anything else.

231 Freeport Road authorize a letter to the property owner – Manager Ulanowicz asked if we can authorize Solicitor Dalfonso to send a letter saying we need in writing who the property manager is and that we can work with them. Council was fine with this.

# **New Business**

Authorize Sam Dalfonso to send a letter to David and Craig Carr at 537 Fountain St to access the water shut off – the water shut off is not accessible and the water bill is excessively high. The shut off is buried about 12 ft. deep and it has shifted so you can not get the key on it. Council was fine to send a letter.

Decorative Lights – We have none in stock. We are ordering a new one, cross your fingers that none get hit before we get a new one.

Codification of Ordinances – We will be codifying ordinances number 623-629 which will be about \$7,000. We are able to transfer EIP funds to pay for this.
